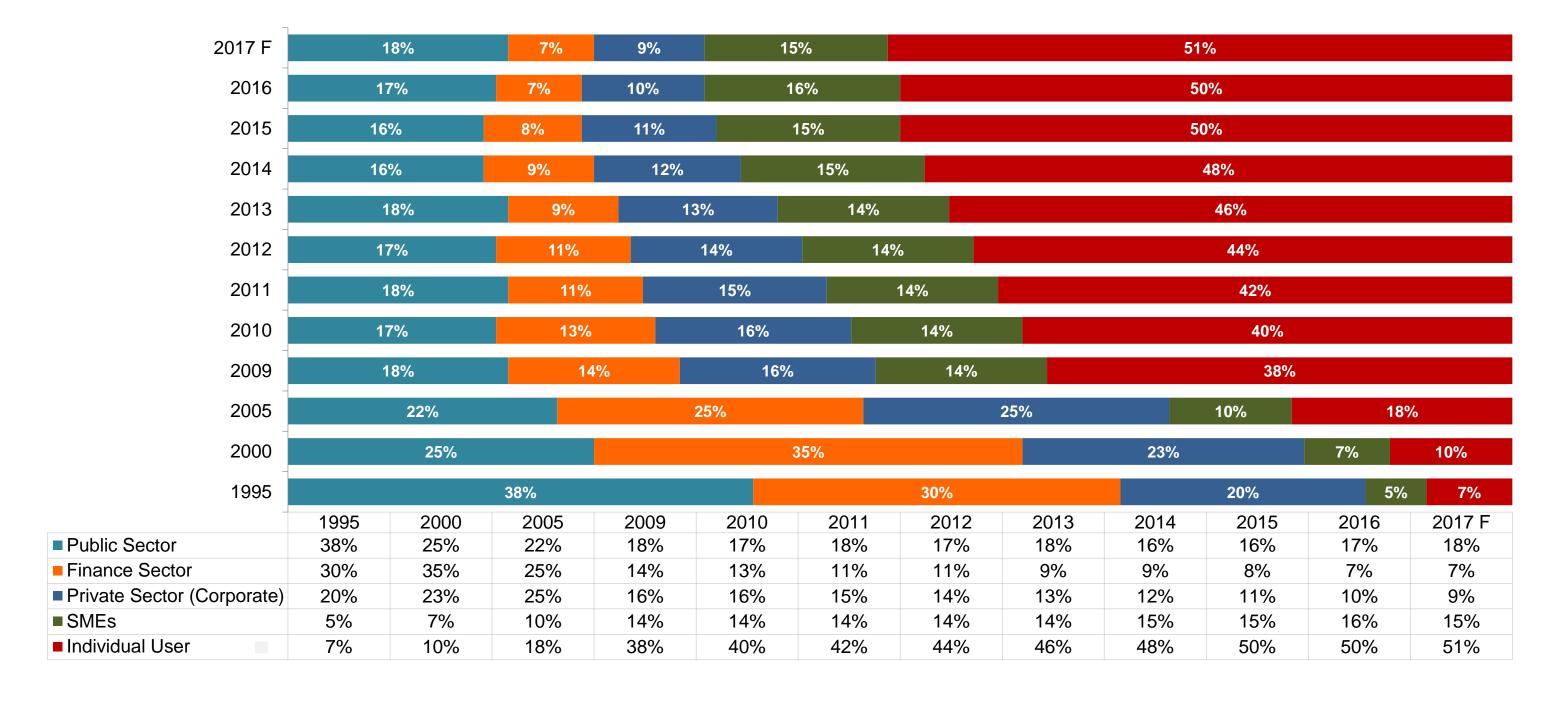

Changes in End User Market Shares









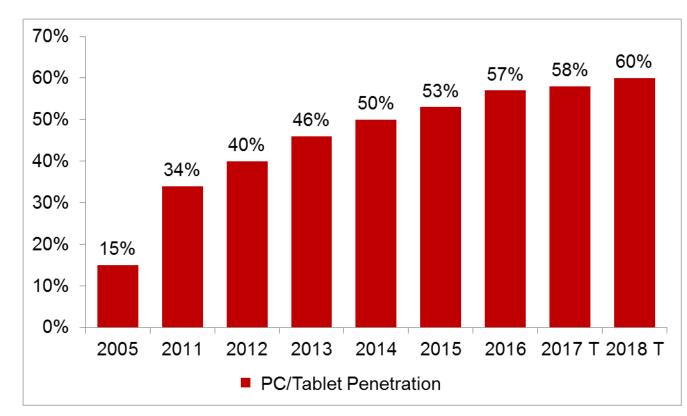
